A total of 20,725 families with dependent children with an average of 2.35 recipients per case received payments averaging \$191.77 for the month of September. In these 20,725 families there were 48,738 recipients, including 36,720 children, who received payment. The average monthly payment was \$81.55 per recipient.

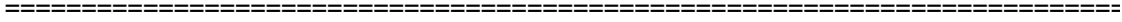

FAMILY ASSISTANCE

Payments by the Department for child care of children totaled \$6,082,629.51 for 25,955 children for the month of September. This included payments totaling \$5,503,801.03 for 22,684 children in Licensed Child Care Centers, \$473,755.78 for 2,236 children in Family and Group Day Care Homes, and \$105,072.70 for 1,035 children in Informal Care. The average monthly payment per child was \$234.35.

The emphasis of the new law is on work activities and employment of recipients. Child care and other supportive services are available to participants.
