**1.0 PROJECT OVERVIEW**

The ALABAMA DEPARTMENT OF HUMAN RESOURCES, (hereinafter referred to as “the Department”) invites qualified vendors to submit proposals to provide **Adult Day Care Services** in North Alabama. This procurement will provide up to ~~154~~ **121** full-time slots of care with transportation or up to the equivalence of 154 full-time slots of care with transportation. **Adult Day Care Services** may be provided one or more of the following counties: *Calhoun, Cherokee, Clay, Cleburne, Colbert, Cullman, DeKalb, Etowah, Fayette, Franklin, Jackson, Jefferson, Lamar, Lauderdale, Lawrence, Limestone, Marion, Marshall, Morgan, Pickens, Randolph, Shelby, St. Clair, Talladega, Tuscaloosa, Walker, and Winston* Counties in Alabama. Recipients of these services are adults who are at risk of abuse, neglect, or exploitation or institutionalization. Adult Day Care offers supervised care in a protective setting for adults who are in need of supervision and/or care outside of the home for a portion of a 24-hour day. A more complete description of the services sought for this project is provided in *Section 3, Scope of Project*. Proposals submitted in response to this solicitation must comply with the instructions and procedures contained herein.
