

Changes have been made to the RFP as originally issued: Please note the changes to 5.0 Cost Proposal:

5.0 COST PROPOSAL

The maximum daily rate for providing transitional living services for children shall be no more than ~~\$99.72~~ **\$82.16. The room and board rate is \$17.56.** The maximum daily rate for providing independent living services for children shall be no more than ~~\$121.30~~ **\$75.60. The room and board rate is \$45.66.** If a vendor provides more than one level of service at a single location, each level of service must be provided in a separate building or wing. SDHR must approve the plan if the services are to be provided within the same physical building.

Vendors proposing to provide both services must submit budgets for proposed Transitional Living and budgets for proposed Independent Living. Vendors must submit separate cost proposals for the following periods: 1) Year 1 for *October 01, 2019 through September 30, 2020*; 2) Year 2 for *October 01, 2020 through September 30, 2021* and 3) Year 3 *October 01, 2021 through September 30, 2022* for the total amount of compensation that will be required to provide this placement meeting the program requirements and the core services outlined in this document. **2019 will be a leap year, please plan accordingly.** The cost proposal form (*Appendix E*) must be completed indicating a daily rate per child and the number of beds offered at the stated rate. *The daily rate is subject to approval by the Department and Medicaid.*

Note: All services provided above and beyond the core services listed, must be authorized by the ISP and on a DHR-1878 to authorize payment of such services.

All services billed as Medicaid Rehab services must be in compliance with Chapter 105 of the Medicaid Rehab Manual and are not to exceed the daily caps.

The parties understand and acknowledge that the vendor may, in certain circumstances and in accordance with the county department's procedures, bill the county department for certain ancillary services. Ancillary services are defined as services, outside program requirements and core services, needed by a child and authorized by the ISP.
