BASIC RESIDENTIAL SERVICES FOR CHILDREN
Evaluation Results and Award Information

The Alabama Department of Human Resources received responses from twenty-one (21) vendors interested in providing basic residential services to children in the custody of the state. The Basic Residential Services for Children Request for Proposals (RFP) announced the availability of 192 slots to be awarded beginning October 01, 2007. Vendors proposed to provide a total of 529 slots, more than double the number to be awarded. The results of this procurement are as follows:
