## INFORMATION TO BE SUBMITTED TO THE DEPARTMENT OF HUMAN RESOURCES BEFORE A DAY/GROUP CARE HOME IS LICENSED

The following information must be submitted to our online system at <a href="https://dhr.alabama.gov/child-care/">https://dhr.alabama.gov/child-care/</a>
before your home can be licensed. This information will be kept in the system by the Department. 1. A completed Application Form (DHR-CDC-712), found on the ARISE portal for providers and uploaded, plus attachments.

The attachments include:

- a. Written permission from the property owner if Rental Property is to be used for child care.
- b. A written statement of compliance with applicable zoning requirements.
- c. A written inspection report with no violations cited from the fire department with jurisdiction or from the State Fire Marshal.
- d. A copy of the written statement of rules and policies of the home. Refer to page 42 of the Standards for Family/Group Day Care Homes and Nighttime Homes for details.
- e. A copy of the home's Emergency Preparedness and Response Plan.
- 2. An Alabama Department of Human Resources Request for Clearance of State Central Registry on Child Abuse/Neglect (DHR-DFC-1598). A Clearance of State Central Registry on Child Abuse/Neglect form must be submitted and results received for the applicant and <a href="mailto:each">each</a> adult household member who lives in the home. Forms are available on the Department's website at <a href="https://www.dhr.alabama.gov">www.dhr.alabama.gov</a>.
- 3. A Criminal History Background Information Check. A criminal history background information check must be completed and results (suitability letters) received for the applicant and <a href="mailto:each">each</a> adult household member who lives in the home. Forms are available on the Department's website at <a href="www.dhr.alabama.gov">www.dhr.alabama.gov</a>.
- 4. A Medical examination report, including TB test date and results, on the required form (DHR-CDC-737) for the applicant and <u>each</u> household member, including each child who lives in the home. A copy of the form can be found on pages 69 and 70 of the <u>Standards for</u> Family/Group Day Care Homes and Nighttime Homes.
- 5. A current Immunization Certificate for each child, two months to five years of age, who lives in the home.
- **6. Verification of Education.** A high school diploma or G.E.D. (General Education Diploma) is required.
- 7. **Verification of training for the applicant.** At least 24 clock hours of training in child care and development are required. Refer to pages 30 and 31 of the <u>Standards for Family/Group Day Care</u> Homes and Nighttime Homes.
- 8. A current Cardiopulmonary Resuscitation Certificate (CPR) and a current First Aid Certificate.
